- 2 **SEC. 5032. VISIBLE DETERRENT.**
- 3 Section 1303 of the Implementing Recommendations
- 4 of the 9/11 Commission Act of 2007 (6 U.S.C. 1112) is
- 5 amended—
- 6 (1) in subsection (a)—
- 7 (A) in paragraph (3), by striking “; and”
- 8 and inserting a semicolon;

1 (B) in paragraph (4), by striking the pe-
2 riod at the end and inserting “; and”; and

3 (C) by adding at the end the following:

4 “(5) if the VIPR team is deployed to an air-
5 port, shall require, as appropriate based on risk,
6 that the VIPR team conduct operations—

7 “(A) in the sterile area and any other
8 areas to which only individuals issued security
9 credentials have unescorted access; and

10 “(B) in non-sterile areas.”; and

11 (2) in subsection (b), by striking “such sums as
12 necessary for fiscal years 2007 through 2011” and
13 inserting “such sums as necessary, including funds
14 to develop not less than 60 VIPR teams, for fiscal
15 years 2016 through 2017”.

16 **SEC. 5033. LAW ENFORCEMENT TRAINING FOR MASS CAS-**
17 **UALTY AND ACTIVE SHOOTER INCIDENTS.**

18 Section 2006(a)(2) of the Homeland Security Act of
19 2002 (6 U.S.C. 607(a)(2)) is amended—

20 (1) by redesignating subparagraphs (E)
21 through (I) as subparagraphs (F) through (J), re-
22 spectively; and

23 (2) by inserting after subparagraph (D) the fol-
24 lowing:

1 “(E) training exercises to enhance pre-
2 paredness for and response to mass casualty
3 and active shooter incidents and security events
4 at public locations, including airports and mass
5 transit systems;”.

6 **SEC. 5034. ASSISTANCE TO AIRPORTS AND SURFACE**
7 **TRANSPORTATION SYSTEMS.**

8 Section 2008(a) of the Homeland Security Act of
9 2002 (6 U.S.C. 609(a)) is amended—

10 (1) by redesigning paragraphs (9) through (13)
11 as paragraphs (10) through (14), respectively; and

12 (2) by inserting after paragraph (8) the fol-
13 lowing:

14 “(9) enhancing the security and preparedness
15 of secure and non-secure areas of eligible airports
16 and surface transportation systems.”.
