

DEAR FRIEND,

I am proud to have several veterans in my family and to serve a state with one of the highest rates of military volunteerism in the nation. Veterans deserve more than just words of gratitude for their sacrifice when they return home. They deserve the quality care and benefits they earned. In my new role this Congress as the Chairman of the Military Construction, Veterans Affairs, and Related Agencies Appropriations Subcommittee, I oversee funding for the U.S. Department of Veterans Affairs (VA). I am committed to fighting for all the resources and funding VA needs to keep America's promise to our service members and their families.

Veterans have faced unique challenges during the pandemic and economic crisis. The American Rescue Plan that President Biden signed into law earlier this year provides billions of dollars in emergency funding for the Veterans Health Administration to deliver health care to veterans who may have delayed care or more complex health care needs as a result of the pandemic. I fought to include strong funding levels for COVID-19 related care, improving telehealth services for rural veterans, and supercharging our vaccine distribution campaign for veterans. I also fought to include \$1 billion in funds so VA can waive co-payment debt of veterans, and stop collecting co-pays for the rest of this fiscal year.

The rescue package also provides support for veterans experiencing unemployment and homelessness. That includes \$386 million to create a Veteran Rapid Retraining Assistance Program for veterans who are unemployed due to COVID-19. It will provide up to 12 months of training and employment assistance for veterans to enter high-demand jobs. There is \$272 million directed toward substantially reducing the backlog of disability compensation and pension claims and appeals in the Veterans Benefits Administration. Finally, we included expanded support for programs that assist veterans experiencing homelessness, and additional funding for state veterans homes to improve the living conditions of our most vulnerable veterans.

My office has helped hundreds of veterans across New Mexico access their care and benefits. If you or a family member is having trouble filing a claim with VA, receiving benefits, accessing health benefits or military records, replacing medals, or other veterans issues, you can contact my office by calling (505) 346-6601 or by visiting the Veterans Resources Center on my website, Heinrich.Senate.Gov.

VISITING THE RAYMOND G. MURPHY VA MEDICAL CENTER

In February, I visited the Raymond G. Murphy VA Medical Center in Albuquerque to discuss the needs of New Mexico's military veterans and their families. During my visit, I toured the new Fisher House and the VA's Field Hospital and took time to thank VA officials and medical staff for their roles in providing COVID-19 testing and vaccine services to area-veterans, and for opening the medical center's ICU beds to non-veterans from the Navajo Nation during the

pandemic.

I also spoke with Medical Center Director Andrew Welch about the expansion of the Spinal Cord Injury Center. The Albuquerque Expand Spinal Cord Injury (SCI) project was approved and included in the VA's FY21 budget request. The construction project has a total estimated cost of \$13.75 million, and will expand the existing SCI unit by approximately 13,250 square feet, including the addition of 10 private rooms to increase patient privacy.

AMERICAN RESCUE PLAN ACT VETERAN HIGHLIGHTS MORE INFO

Additional funding for the Veterans Health Administration

Provides \$14.5 billion for health care services and additional resources to care for our nation's veterans.

Prohibit copayments for medical

Allows VA to waive copays that would otherwise be charged to veterans for VA health care services during this unprecedented health emergency.

Secure assistance for unemployed veterans

Provides nearly \$400 million to help get veterans back to work by funding the Veteran Rapid Retraining Assistance Program.

Increase claims and appeals processing

Provides VA \$272 million to mitigate the backlog in claims processing caused by the pandemic.

Bolster VA's supply chain modernization

Provides \$100 million in funding to accelerate VA's supply chain modernization, which is crucial for improving the Administration's public health emergency response.

Support State Veterans Homes

Provides \$500 million to help states upgrade State Veterans Homes and \$250 million in one-time emergency payments to support these facilities.

Fund stronger oversight

Provides \$10 million to help VA's Office of Inspector General continue their stringent oversight of VA's response to the pandemic.

Emergency Employee Leave Fund

Includes \$80 million to provide certain VHA personnel with paid emergency leave.

DEFENDERS OF BATAAN AND CORREGIDOR CONGRESSIONAL GOLD MORE INFO

Tens of thousands of Americans and Filipinos—including many New Mexicans - demonstrated incredible and courageous fortitude during World War II's Bataan Death March. Bataan veterans deserve the recognition of our nation's highest and most distinguished honor for their perseverance and patriotism. That's why I introduced the Defenders of Bataan and Corregidor Congressional Gold Medal Act to bestow a collective Congressional Gold Medal to the troops from the United States and the Philippines who bravely defended Bataan and Corregidor and endured one of the most harrowing prisoners of war experiences in history. America owes its Bataan veterans a debt of gratitude that can never be repaid. These brave soldiers demonstrated courage in the face of captivity and inhumanity. We must never forget their undaunted heroism in the face of unthinkable conditions and horrific abuses.

Despite the unprecedented challenges brought about during 2020, I'm happy to report Congress passed some remarkable Veterans Legislation during the 116th Congress. In case you missed it, here are some of the bills I was happy to support in becoming law:

BLUE WATER NAVY VIETNAM VETERANS ACT OF 2019

- Extends the presumption of herbicide exposure, such as Agent Orange, to nearly 90,000 veterans who served in the offshore waters of the Republic of Vietnam between Jan. 9, 1962 and May 7, 1975.
- Expands VA benefits to children with spina bifida whose parent was exposed to a herbicide agent while serving in Thailand between January 9, 1962, and May 7, 1975.
- Revises the VA home loan guaranty program to adjust loan fee rates and eliminate the limit on the amount of a loan for which the VA may provide a guaranty of 25%.
- Removes the cap on a direct housing loan amount that may be made to a Native American veterans purchasing a home located on tribal land held in federal trust.
- Waives loan fees for active-duty Purple Heart recipients.

VETERANS' COMPENSATION COST-OF-LIVING ADJUSTMENT ACT OF 2020 MORE IN

- Increased rate of compensation for veterans with disabilities.
- Increased clothing allowance.
- Increased compensation for dependents.
- Increased compensation to surviving spouse.
- Increased compensation to children.

COMMANDER JOHN SCOTT HANNON VETERANS MENTAL HEALTH CARE IMPROVEMENT ACT OF 2019 MORE INF

Helps increase outreach and services to veterans at risk of suicide and improves VA mental health services by:

- Improving transition from active-duty service to veteran status.
- Encouraging and incentivizing mental health professionals to work in the VA.
- Improving access, especially rural access, to mental health services.
- Increasing funding for certain suicide prevention efforts.
- Funding to integrate mental health efforts with supportive communities outside of the VA.
- Expanding veteran access to health programs.
- Supporting expanded research on mental health conditions among veterans.

Austen, age 91, was initially awarded these medals and commendations after serving in three campaigns in Korea, but had never received them. More than 65 years later, Mr. Austen finally received recognition for his service to our country.

AIRBORNE HAZARDS AND OPEN BURN PIT REGISTRY

I welcome President Biden's recent announcement that all American servicemembers will withdraw from Afghanistan by September 11, 2021. The war in Afghanistan is now by far the longest in American history, and I am grateful for the contributions of all who have served over these past two decades. We know the challenges of war are not all left behind on the battlefield when the time comes for our service men and women to pack up and come home.

It's estimated that over the course of the first Gulf War and 20 years of warfare in Southwest Asia since 9/11, about 3 million veterans have been exposed to burn pits and other airborne hazards that can have long-term impacts on their health. Fewer than 300,000 of these 3 million veterans with possible exposure have signed up for the VA's Airborne Hazard and Open Burn Pit Registry. If you know a veteran who may have been exposed to these toxic environments, please tell them about the registry and encourage them to share any possible exposure with their healthcare provider. The more veterans who sign up, the better the VA will understand the long-term effects of these exposures and



more veterans will be connected to the health care they've
